As daylight saving ends and the autumn colours emerge, it seems a lot longer than three months ago that we were all taking a well-earned rest and enjoying some long summer evenings. The National Office Team started the year hopeful of less disruption but also well prepared for ongoing change and well-practised in resetting when plans have had to change. That's been fortunate given the dynamic situation during the Omicron outbreak. We continue to adapt with the team currently working in two bubbles between the office and home to minimize the impact of COVID related disruption.

As always the first quarter of the year has been a busy one. Our online remits session was the first one in the history of the organisation and it was great to see that online approaches can work when we need them for these important discussions.

We have also been supporting the Scotlands Te Kiteroa Grant and the RWNZ Bursary Committees who had difficult decisions to make with significant interest in these grants and a high volume of applications.

This quarter also saw the recruitment and appointment, and now induction, of our two Connectors who started with us in mid-March. They are enjoying learning about our organisation and have hit the ground running providing support to Region 6 Greater Waikato and Region 1 for events planned in April.

In addition, we have worked to support the Board in preparing for the roll out of the Contestable Fund initiative and in its Strategic Planning work.

Progress on our policy focus areas has continued over this time with active involvement in the creation of the Women's Employment Action Plan, ongoing participation in several important groups including the collective of organisations focussed on rural health (RHAANZ), the nation-wide social inclusion work where we are represented by Board Member, Sharron Davies-Martin and the Rural Crime Prevention Partnership.

We also endeavour to keep Members up to date with opportunities to learn about proposed legislative or regulatory changes. By the time you read this Express, we will have had our webinar with Taumata Arowai, the new water regulator, and will also be in the midst of consultation regarding the proposed changes regarding Afforestation.

One of the highlights of the past few months has been seeing the growth in interest in our "Black Heels and Tractor Wheels" podcast. We were delighted to receive this feedback from one listener.

Contestable Fund

At the AGM held in November, the Rural Women New Zealand (RWNZ) Board announced the creation of the Contestable Fund totalling \$90,000 to be dispersed over a three-year period.

The purpose of this Fund is to fulfil RWNZ's strategic intent of strengthening, supporting and connecting people and communities by encouraging and supporting initiatives and projects that will grow RWNZ's membership.

The fund is intended to support Members who wish to undertake new projects and initiatives that offer positive experiences for current and potential Members of RWNZ and build the profile of RWNZ as a vibrant, relevant progressive organisation.

Applications can be made by a Member; a Branch or Group; a Provincial or a Region. The Leadership team of the relevant Region will be part of the discussions and consultation regarding the application.

As part of the application process, applicants will be asked to provide details of their project including a project plan and their goals for the project.

Applications to the fund open on 19 April (post Easter). The application form which includes the criteria and supporting documentation will be available on the Members only section of the RWNZ website or on request from the National Office from that date.

Applications will be considered when received and contact will be made with the applicant to discuss the timeframe for a response.

We look forward to receiving applications with a range of wonderful ideas.

SUPPORT FOR UKRAINE

Following requests from Members regarding how we can support Ukraine, we contacted ACWW to seek understanding of the best way to support rural women in Ukraine. It is a very difficult situation, as ACWW has no mandate or practical ability to do emergency aid work.

ACWW has issued a statement and is approaching the crisis in the ways they are able. Here is further comment about this from Nick Newland, Policy and Communication Manager for ACWW.

ACWW has been lobbying for action with the UK government and at the UN.

The frustration and concern in only being able to offer a statement is palpable and no one feels that statements are enough, however they are what ACWW has within its power to offer.

At the United Nations, there are moves under way to challenge the Russian Federation's right to sit on the Security Council, and thus hold a veto vote in deliberations. Whilst it has always been widely understood that the Russian Federation inherited the seat on the SC from the USSR, this was never formally codified and therefore there is nothing in the UN Charter that provides the Russian Federation with a seat on the Security Council. This move, if successful, would have significant impact on the situation:

- Russia would no longer be able to veto decisions at the Security Council including decisions regarding deployment of peacekeepers or other initiatives.
- b. Removing Russia from other mechanisms, such as the Human Rights Council, requires a motion from the Security Council to the General Assembly if Russia cannot veto this at the SC then there is a greater chance of such a motion making it to the GA.
- c. It would be a massive loss of status, and have long-lasting implications for President Putin's regime.

There are also significant pressures being applied in diplomatic circles to isolate Russia from human rights mechanisms such as the Commission on the Status of Women, as it is blocking civil society access. This would potentially have long-lasting positive implications; if Russia is unable to block progress and unable to add regressive language into human rights (and specifically women's rights) processes at the UN, then those treaties become stronger and have greater potential for legal enforcement (depending on the status of the treaty).

This might sound like a lot of talk and not much action, however it can and will have an impact on both the Russian government and hopefully a positive one on the peoples of both Russia and Ukraine. In October 2021, I met with the Russian Minister for Rural Affairs (along with ACWW Executive Director Tish Collins, and World President Magdie de Kock). I asked him whether he participated in the production of reports for CEDAW (the Convention on the Elimination of Discrimination Against Women), as Article 14 is centred on the rights of rural women. His response was a simple "no". Having challenged him on the implications of this, ACWW was also then able to inform our members in Russia who started to pursue this through their own legal channels. It is not a fast process, and it is not comprehensive, but ACWW does whatever it is able to do to help its members, and to hold governments to

We suggest that members donate to Red Cross, UNICEF and other recognised charities able to provide practical support to those in need in Ukraine.

Women's Employment Action Plan

As part of our contribution to the Government's Women's Employment Action Plan, RWNZ developed and conducted a Nature of Work survey. We are currently analysing the results and combined with earlier research for the Quality of Life Report and the future workforce survey, we will have a comprehensive report with a list of recommendations for the Government.

One of the recommendations will be that we need further research especially given that rural women, their work and issues impacting them has not been studied since 1989.

Many thanks to those of you who have shared your lived experience with us to inform this work. We will share the report when it is completed.

The Committee will be meeting via Zoom in the upcoming weeks to get on with the business of overseeing planning for epic centennial celebrations for 2025. The substantive role of the Committee is to establish a timeline and milestone dates for consultation with Members and the development and implementation of Centennial projects and events.

The first phase of the Committee's work is seeking your ideas for potential projects, events, commemorations, memorabilia and celebrations for our centennial year. You are warmly encouraged to share your thoughts and ideas for local, regional and national celebrations with the Committee members directly or by calling or emailing Lisa at the National Office. Once the Committee has all your suggestions, it can start to plan out what our centennial year might look like and how we might bring those great ideas to fruition.

The Archives Project

In December 2021, RWNZ's volunteer Summer Research Scholar Gyle Bascon joined us in the National Office to further the devised work plan for the RWNZ Archives Project. Gyle's study majors in both History and Information Management Systems made her the perfect candidate for this section of the project.

Gyle's main responsibilities involved researching and designing an Information Management System (IMS) which would appraise, organise, document, reference and preserve RWNZ's existing archival materials. The outcome of which would ensure that RWNZ's archives could be accessible to Members for both ongoing and general research purposes and also for the approaching Centennial Celebrations in 2025.

The first steps of this work involved creating multiple, project specific, business process models from which to design a pathway for managing the existing archives. These models were a broad overview of how RWNZ's archival material could be appraised, organised, documented, referenced and searched. Based on these defined models, a clear information management system could be produced.

Gyle then began to research 2 different IMS options: One was a prototype based on pre-existing open source



software which could be further developed and refined to suit the specific needs of RWNZ. The second option was based on the use of a system utilising Excel spread sheeting software which had a similar template model to that of a discontinued "community Archives" software a resource once available – but no longer - through Archives NZ.

The final step of this phase of the Project involved investigating how RWNZ's archives could be preserved. Gyle investigated various offsite storage facilities for physical items, and identified potential archival software that RWNZ may be able to use in the future.

Control the QUAD roll. Protect what matters most.

Fairlie farmer Andrew Hurst purchased a crush protection device (CPD) for his quad bike more than a decade ago and it's saved him twice from serious injury. Once with a bull that charged his bike whilst chasing his dog in a completely flat paddock, and again when he rolled it in a swamp. "It was like someone pushing firmly on my back with both hands, I look up and here's the bike back on its wheels again." CPDs were deemed a personal choice by Worksafe in 2014, but a thorough review of the research led them to take a firmer stance. Along with Safer Farms and ACC, they now "strongly recommend" the use of professionally designed and manufactured CPDs on the back of quad bikes. CPDs create a gap between the bike and the ground that could aid survival during a roll over. Safer Farms Chairperson Lindy Nelson highlights "if farmers find themselves in a situation they did not intend to be in, roll over protection could make all the difference."

These cushions have brought relief to women going through dark days in the most practical of ways. This message was sent to us in August 2019 by the recipient of one of the breast comfort cushions:

"Hello there, I've received one of the breast pillows post-mastectomy this week that your organisation has produced and want to thank you for this gift. The physical comfort from this pillow was immediate post-op but the psychological comfort was unexpected. Leaving the hospital with this lovely heart-shaped cushion under my arm and over where my breast had been removed enabled a greater feeling of physical wholeness that enabled me to feel a little less disfigured. Thank you so much for this gift as it has enabled me to feel a little more whole in these initial days. Many thanks to those involved in providing this initiative."

Recently, we received some information from Rachael Dean (Region 4) who is involved with an American organisation called Sweet Marigolds whose members also make breast comfort cushions. Recently, Rachael passed on the details about another product that the Sweet Marigolds make - aprons that can accommodate post mastectomy drains. The apron helps hold the drains in place and decreases pulling on the surgical sites while the patient recovers.



In Memory Of

Ailsa Lovett

National Member of Honour, National Life Member, Provincial Life Member

6 June 1929 – 18 January 2022 (aged 93 years)

Lynnford Rural Women has sadly lost one of its long serving and most active members, Ailsa Lovett passed away on 18th January 2022 in Ashburton.

Ailsa's links to Rural Women goes way back to 1950 when she first joined the Flemington Branch of Women's Division of Federated Farmers later becoming Vice President in 1954 and a Delegate to the Mid Canterbury Executive in the same year. Whilst at Flemington Ailsa held numerous positions such as Treasurer, Branch Secretary and became President in 1959, representing Flemington at the Dominion Conference in Wellington. Her rapid rise in positions showed her dedication to our local organisation.

Ailsa went on to become Vice President for the Mid Canterbury Provincial in 1973 and was a representative at the Dominion Conference in Tauranga 1974. Her work for Rural Women was tireless. In 1977 Ailsa became the Provincial President followed in 1979 with her election on to the Dominion Council as the South Island Vice President. This was a very proud moment for her and she was awarded Provincial Life Membership in 1982 followed by Dominion National Life Membership in 1987 When the Flemington Branch went into recess Ailsa transferred to the Lynnford Rural Women's Division.

An address from the world president of The Association of Country Women of the World [ACWW] inspired Ailsa to take the aims of this organisation back to her Flemington branch and to dedicate time and effort in helping improve the conditions and life chances for women throughout the world. Alisa's work with ACWW remained close to her heart taking her around the world to numerous conferences and conventions.

In her later years Ailsa continued to attend as many meetings as possible with the Lynnford Branch often meeting at her Rosebank rest home. Her dedication to the work of the Rural Women NZ was tireless and her knowledge and experience will be greatly missed.

In Memory Of

Dorothy (Dot) Taylor

Dot joined WDFF/ RWNZ as a young bride and by the time her twins were toddling around, she was Branch President and often had the boys sat either side of her at the President's table. She became a Branch representative at Franklin Provincial meetings and then was



appointed Provincial Treasurer - a position she held for at least 14 years. It was an onerous duty, marshalling at least 10 branches and all their Annual records, balance sheets etc. to go to Head Office in Wellington. At that time we also had an Emergency Housekeeping scheme and Dot assisted the Housekeeping Secretary with PAYE and tax returns.

Dot was a regular delegate at National Conferences and became well known in other Provincials. Dot was honoured with the presentation of Provincial Life Membership in recognition of her work for WDFF. We always enjoyed having Dot at our meetings and even in the last couple of years when she couldn't attend, she was always interested in what was happening. One of our younger members said how much she cherished the memory of Dot joining us in a wheelchair to march in the Suffrage 125 Anniversary Parade. Dot loved that so many she hadn't seen for quite a while came up to say hello. She will be missed.

Pat Mclauchlan who died on 2nd November 2021, aged 94.



Marion writes across several genres including biography, short story, children's picture books and educational books; many of our readers will have seen her beautiful coffee table book, *Passion*.


