Registration of interest for Reserve Bank community cash service trials

The withdrawal of banking services from rural areas is something we have consistently campaigned on.

We encourage members to spread the word in their communities about taking part in the upcoming Reserve Bank community cash service trials.

The trials look to find solutions to problems rural retailers have with bank takings and obtaining change in locations lacking over-the-counter bank or ATM cash services.

The trials will kick off from August/September and will focus on the important role of retailers in local cash circulation.

Registrations of interest are invited from business, community, local government or iwi leaders on behalf of communities of 1,000 to 10,000 residents with limited or no bank over-the-counter cash services or ATMs.

Reduction in rural post services

Rural Women CE Gabrielle O'Brien was recently interviewed as part of RadioNZ's Rural News programme about NZ Post phasing out Saturday newspaper and parcel deliveries.

Her message was that while we understand the business rationale behind reducing the frequency of rural postal services, with a range of connectivity issues in rural communities, rural post and newspapers still play an important link.

Member concerns about the withdrawal of copper landlines

We have had some members express concern that Chorus will remove their copper landlines even though they don't have access to a fibre connection.

We want to reiterate that Chorus can only stop supplying copper services where households can access the same services over the fibre network. In areas where fibre is not currently available, Chorus must continue to supply copper services.

Changes to Health NZ's National Travel Assistance Scheme

Health New Zealand has recently made changes to the National Travel Assistance (NTA) scheme.

The scheme helps people access specialist health care who need to travel long distances or travel frequently by contributing to their travel and accommodation costs.

A number of changes to the NTA scheme have been announced. From 1 April 2024:

- \* mileage rates will rise from 28c to 34c a kilometre, and
- \* nightly accommodation rates will rise from \$100 to \$140 a night. The rate for those staying with friends or whānau will increase from \$25 to \$35 a night.

NTA applicants can now email their claims through to claimsmanagement@health.govt.nz

In the near future they also intend to:

- \* introduce easier pre-payment and claiming options,
- \* make eligibility changes to better target those in need, and
- \* better promote and increase awareness of the scheme.
